

# The Medicine Way

Vaccine Exemption Statement:

We hereby assert our right to a religious exemption from vaccination. We are spiritual people who believe in ***The Medicine Way*** teachings. We are spiritual beings. This perspective recognizes that faith and conscience compel an individual to submit to the proper jurisdiction within the rule of law, in this case, Divine Law.

We are objecting to vaccines because we believe in and follow the principles laid out in ***The Medicine Way*** teachings and we have a deeply held belief that vaccines violate them. We believe our body is a temple for our Spirit.

Specifically, ***The Medicine Way*** teaches that:

We are the temple for our Spirit, and that our Spirit dwells in our temple. Our temple is divine and we will not allow anyone or thing to defile it. Our temple is holy and houses our Spiritual Being.

Accordingly we believe, pursuant to our faith, that our body is a temple of our Spirit. It is a given responsibility and requirement for us to protect the physical integrity of our body against unclean food and injections.

Vaccines contain neurotoxins, hazardous substances, attenuated viruses, animal parts, foreign DNA, albumin from human blood, carcinogens and chemical wastes that are proven harmful to the human body.
